**What?**

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and Checking account information
- Account balances and Account Transactions
- Credit history and Payment history

**How?**

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons BankSouth chooses to share; and whether you can limit this sharing.

Why can't I limit all sharing?

- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?

## Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates include BankSouth Mortgage, LLC; BankSouth Insurance, LLC; Forty-Four Holdings, LLC; Coldwell Banker Lake Oconee Realty; BankSouth Holding Company*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *BankSouth does not share with nonaffiliates so they can market to you.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Our joint marketing partners include investment companies, insurance companies, and affinity financial service companies.*
